

**EAGLE MOUNTAIN CITY
NOTICE OF PETITION FOR ANNEXATION
OF AN AREA KNOWN AS
THE BUTTERFIELD ANNEXATION
AND CERTIFICATION OF PETITION**

A Petition for Annexation has been filed with Eagle Mountain City proposing the annexation of an area to Eagle Mountain City known as the "Butterfield Annexation." The Eagle Mountain City Council received Notice of Certification of the annexation petition on July 15, 2020. The area proposed for annexation is described as follows:

BEGINNING AT THE NORTHEAST CORNER OF SECTION 14, TOWNSHIP 5 SOUTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE, SOUTH 00°10'27" WEST, ALONG THE SECTION LINE COMMON WITH SECTIONS 13 AND 14, A DISTANCE OF 2676.08 FEET TO THE EAST QUARTER CORNER OF SAID SECTION 14; THENCE, NORTH 89°02'13" WEST, ALONG THE EAST-WEST CENTERQUARTER LINE, A DISTANCE OF 2687.78 FEET TO THE CENTER QUARTER CORNER OF SAID SECTION 14; THENCE NORTH 01°04'15" EAST, ALONG THE NORTH-SOUTH CENTER QUARTER LINE, A DISTANCE OF 1328.13 FEET TO THE EAST-WEST 40-ACRE LINE OF THE NORTHWEST QUARTER OF SECTION 14; THENCE, NORTH 89°02'48" WEST, ALONG SAID EAST-WEST 40-ACRE LINE, A DISTANCE OF 1356.42 FEET TO THE NORTH-SOUTH 40-ACRE LINE OF SAID NORTHWEST QUARTER OF SECTION 14; THENCE NORTH 00°45'35" EAST, ALONG SAID NORTH-SOUTH 40-ACRE LINE, A DISTANCE OF 1327.91 FEET TO THE SECTION LINE COMMON WITH SECTIONS 11 AND 14; THENCE, SOUTH 89°03'23" EAST, ALONG SAID SECTION LINE, A DISTANCE OF 1363.63 FEET TO THE NORTH QUARTER CORNER OF SAID SECTION 14; THENCE, SOUTH 89°27'38" EAST, ALONG THE SECTION LINE COMMON WITH SECTIONS 11 AND 14, A DISTANCE OF 2646.02 FEET TO THE NORTHEAST CORNER OF SECTION 14 AND THE POINT OF BEGINNING OF THIS DESCRIPTION.
CONTAINS 204.69 ACRES (MORE OR LESS)

Eagle Mountain City may grant the petition and annex the area described in the petition to the City, unless written protest(s) to the annexation petition is filed with the Utah County Boundary Commission and a copy of the protest delivered to the Eagle Mountain City Recorder. Protests shall be filed with the Utah County Boundary Commission, ATTN: Gary Radcliff, Chair, at 2855 South Street, Provo, Utah 84606 between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday, except holidays. A copy of the protest shall also be delivered to Fionnuala B. Kofoed, Eagle Mountain City Recorder, 1650 E. Stagecoach Run, Eagle Mountain, Utah 84005.

A protest to the annexation may be filed by the legislative body, a governing body of an affected entity, or the "owner of rural real property" according to UCA 10-2-407. The deadline for filing protests to the Butterfield Annexation Petition is 5:00 p.m., August 14, 2020.
