# NOTICE OF ADOPTION OF ORDINANCE <u>O-10-2021</u> BY THE EAGLE MOUNTAIN CITY COUNCIL

Pursuant to Sections 17C-5-109 and 17C-5-110 of the Utah Code Ann., the Eagle Mountain City Council (the "City Council") is providing this notice with respect to Ordinance O-10-2021 which was passed by the City Council on March 16, 2021, adopting the official Sweetwater Industrial Park Community Reinvestment Project Area #2 Plan (the "Official Plan"), as approved by the Eagle Mountain Redevelopment Agency (the "Agency") on the same date, and directing that notice of adoption of the Official Plan be given as required by law. Ordinance O-10-2021 and the Official Plan shall become effective upon publication of this notice, at which time the Agency may proceed to implement the Official Plan. The Official Plan is available for general public inspection at the office of the City of Eagle Mountain, 1650 E. Stagecoach Run, Eagle Mountain, Utah during regular office hours, Monday through Friday.

For a period of 30 days after the date of adoption of the Official Plan, any person in interest may contest the Official Plan or the procedure used to adopt it if the Official Plan or procedure fails to comply with applicable statutory requirements. After expiration of that 30-day period, no person may contest the Official Plan or procedure used to adopt it for any cause.


