RESOLUTION NO. 13 -99

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF EAGLE MOUNTAIN, UTAH RATIFYING TEMPORARY REDUCED BUILDING PERMIT FEES

The Town Council of the Town of Eagle Mountain, Utah finds that it is in the public interest to expedite the issuance of certain building permits which have been approved by the Town, but which have not been issued to the permittee because the Town has limited space for the storage of plans and other materials related to pending building permits and desires to encourage the permittees to pick up the building permits to alleviate space conditions in the Town office. The Council further finds that it is equitable to reduce the final building permit fee payment by the sum of \$200.00 when and if permittees obtain and pay for pending building permits by the close of business July 30, 1999. The Town Council of the Town of Eagle Mountain approved the temporary reduction of the building permit fee for permits paid for and received prior to July 30, 1999, and now desires to ratify the temporary reduction as provided specifically in this resolution.

NOW THEREFORE, be it resolved by the Town Council of the Town Eagle Mountain, Utah as follows:

1. The building permit fee for the following permittees is discounted \$200.00 and each of the following building permit fees are considered paid in full based on the permittees payment for and receipt of the following building permits prior to close of business July 30, 1999.


