## RESOLUTION NO. 97-53 ADOPTING NEW NATURAL GAS SERVICE CONNECTION AND RATE SCHEDULES

WHEREAS, The Utilities Ordinance of the Town of Eagle Mountain provides that the Town Council shall fix rates to be charged by the Town for Natural Gas service.

WHEREAS, the Council desires to adopt Natural Gas Service Extension Fees and Connection Fees and Natural Gas Service Schedules; and

NOW, THEREFORE, BE IT RESOLVED by the Eagle Mountain Town Council;

Natural Gas Connection Fees: These connection fees shall be paid for at the time of Town Council approval and before any construction on the property occurs.

Residential

\$300

Commercial

\$ (To be determined by service requirements)

<u>Deposits</u>: Deposit fees are necessary to protect the Town from loss from unpaid monthly gas billings. The deposit shall be the equivalent of two months service or a minimum of \$40.00. After customers have one year with a record of timely payment the deposit will be refunded.

<u>Natural Gas Service Extension Fees</u>: Extension fees to be based on the actual cost of extending service to site or subdivision. The developer shall be responsible for the costs of the installation of natural gas system service within the subdivision or development. Fees for both the extension of service to a subdivision, or site, and installation of service within a subdivision shall be paid prior to recording of the subdivision plat, or issuance of a building permit, and before any construction occurs on the property.

Natural Gas Service Schedules. The rates in Natural Gas Service Schedule shall be as follows:

## Schedule No. I

Customer charge:

\$5.00 per service connection per month

Natural Gas charge

Summer:

\$3.70 per Decatherm

Winter:

\$4.50 per Decatherm

Minimum:

\$5.00 for residential customer fee \$10.00 for commercial customer fee

<u>Invalidity</u>: Any provision of this Resolution held invalid shall be ineffective to the extent of such invalidity without affecting or invalidating the remaining provisions of this Resolution. Natural Gas Connection Fees and Service Schedule No. I shall remain unchanged and in full force and effect.

Effective Date: This Resolution is effective at its first posting or 12:01 A.M. October 1, 1997.
