RESOLUTION NO. 97-54 WATER SYSTEM RATE SCHEDULE

A Resolution adopting the Water System Rate Schedule as authorized by the Utilities Ordinance of the Town of Eagle Mountain, Utah.

WHEREAS, the Utilities Ordinance provides that the Town Council shall from time to time by Resolution, establish such rates and fees as it deems proper for the water service provided by the Town, and

WHEREAS, the interest of the public and individual customers can be served best by reasonable rates and charges for water service and a self funded water utility;

NOW, THEREFORE, be it resolved by the Town Council of Eagle Mountain, Utah, that the following is hereby adopted as the Eagle Mountain water rate schedule.


Deposits: Deposit fees are necessary to protect the Town from loss from unpaid monthly water billings. The deposit shall be the equivalent of two months service or a minimum of \$40.00. After customers have one year with a record of timely payment the deposit will be refunded.

Water Service Extension Fees: Extension fees to be based on the actual cost of extending service to site or subdivision. The developer shall be responsible for the costs and installation of the water system service within the subdivision or development. Fees for the extension of service to a subdivision or site shall be paid prior to recording of the subdivision plat, or issuance of a building permit, and before any construction occurs on the property.

Effective Date: This Resolution is effective at its first posting or 12:01 A.M. October 1, 1997.


